Project Objective:	The goal of the project is to increase citizen activity in the influence of central institutions regarding the electoral process in Kosovo, decriminalization of the political scene, prosecution and adjudication of criminal offenses related to electoral deception, public awareness campaign regarding the importance and need for fair and transparent elections, inclusion of the diaspora and promotion of the importance of participation in the elections.
Project Results:	<ol style="list-style-type: none"> 1. Justice in election (KLI) - Advancement of Standard Action Procedures and increase of further cooperation between the Police, the Prosecution and the Courts in dealing with criminal offenses against the elections. 2. Drafting of appropriate legislation or policies regarding the decriminalization of the political scene through which will be treated the issue of candidates that are subject of criminal indictments or judgments for the commission of criminal offenses. 3. Informing and raising the awareness of the importance of active participation in public life and accountability requirement by elected officials. 4. Creating an informal community for advocating of increased participation in the electoral process and public life. 5. Supporting electoral reform by improving the electoral complaints system by identifying obstacles, barriers and challenges at all levels of this system. 6. Advocating findings to all stakeholders in order to improve the electoral complaints system in the Kosovo electoral system. 7. Local media are more informed about the electoral process in Kosovo, and have knowledge about the often irregularities of this process. 8. Improvement of voter participation abroad.
